Across the United States, almost 8.5 million locations lack access to high-speed Internet service. The Biden Administration's Investing in America agenda aims to bridge this divide and connect everyone in America with affordable, reliable, high-speed Internet service. Last year, the Administration launched the Internet for All initiative with \$65 billion from President Biden's Bipartisan Infrastructure Law, \$25 billion from the President's American Rescue Plan, and several other high-speed Internet programs. Internet for All will deliver high-speed Internet infrastructure to every corner of the country, enable working families to afford service, and ensure that everyone has the digital skills and devices they need to fully utilize the Internet. Together, we will close the digital divide and grow our economy from the bottom up and middle out.

\$2,419,264,660.10*	The Coronavirus State and Local Fiscal Recovery Funds (SLFRF) program, funded by President Biden's American Rescue Plan Act, delivers \$350 billion to state, territorial, local, and Tribal governments across the country to support their response to and recovery from the COVID-19 pandemic, including high-speed Internet deployment. *Figure represents dedicated high-speed Internet funding. \$540,200,000.00*	The Capital Projects Fund (CPF) provides \$10 billion from President Biden's American Rescue Plan to states, territories, freely associated states, and Tribal governments to fund critical capital projects that enable work, education, and health monitoring in response to the public health emergency, including high-speed Internet infrastructure. *Figure represents dedicated high-speed Internet funding. \$160,044,759.29	The Tribal Broadband Connectivity Program (TBCP) is a \$3 billion program, from President Biden's Bipartisan Infrastructure Law and the Consolidated Appropriations Act, to support Tribal governments bringing high-speed Internet to Tribal lands, including telehealth, distance learning, affordability, and digital inclusion initiatives. \$90,813,413.00	The ReConnect Loan and Grant Program is a \$1.9 billion program funded through President Biden's Bipartisan Infrastructure Law that provides funds for the cost of construction, improvement, or acquisition of facilities and equipment needed to provide high-speed Internet service in eligible rural areas. \$79,841,185.09	The Enabling Middle Mile Broadband Infrastructure Program provides \$1 billion from President Biden's Bipartisan Infrastructure Law to reduce the cost of bringing high-speed Internet service to unserved and underserved communities by connecting local networks to major networks. \$17,225,000.00	The Telecommunications Infrastructure Loan Program is a \$690 million program which provides low-interest loans to construct, maintain, improve, and expand telephone and broadband services in rural areas.	USDA

\$817,927,801.00	The Affordable Connectivity Program (ACP) provides \$14.2 billion from President Biden's Bipartisan Infrastructure Law to provide eligible households with a discount of up to \$30/month (\$75/month on qualifying Tribal lands) for high-speed Internet service, and up to \$100 discount toward a desktop, laptop, or tablet computer offered by participating Internet service providers.	2,203,701
