Last year, the Administration launched the Internet for All initiative with \$65 billion from President Biden's Bipartisan Infrastructure Law, \$25 billion from the President's American Rescue Plan, and several other high-speed Internet programs. Internet for All will deliver high-speed Internet infrastructure to every corner of the country, enable working families to afford service, and ensure that everyone has the digital skills and devices they need to fully utilize the Internet. Together, we will close the digital divide and grow our economy from the bottom up and middle out.

\$522,111,632.00	The Coronavirus State and Local Fiscal Recovery Funds (SLFRF) program, funded by President Biden's American Rescue Plan Act, delivers \$350 billion to state, territorial, local, and Tribal governments across the country to support their response to and recovery from the COVID-19 pandemic, including high-speed Internet deployment.  *Figure represents dedicated high-speed Internet funding. \$185,000,000.00	The Capital Projects Fund (CPF) provides \$10 billion from President Biden's American Rescue Plan to states, territories, freely associated states, and Tribal governments to fund critical capital projects that enable work, education, and health monitoring in response to the public health emergency, including high-speed Internet infrastructure.  *Figure represents dedicated high-speed Internet funding. \$9,272,013.00	The ReConnect Loan and Grant Program is a \$1.9 billion program funded through President Biden's Bipartisan Infrastructure Law that provides funds for the cost of construction, improvement, or acquisition of facilities and equipment needed to provide high-speed Internet service in eligible rural areas.	Department of Agriculture
\$4,704,351.00	The Community Connect Grants is a grant program which received \$35 million in the FY23 appropriations bill, that provides funding for eligible applicants to construct high-speed Internet networks on a community-oriented connectivity basis in rural areas.	Department of Agriculture
